- 4. **FEE TERMS**: Sanctionee agrees to pay Sanctionor the sanctioning fee of one hundred dollars (\$100.00).
- 5. RULES AND REGULATIONS: Sanctionee agrees to comply with and follow the rules and regulations for the JBBA in regard to the approved show, including that the show be open to all JBBA members in good standing. Sanctionee agrees to submit the results of said show in its entirety to the JBBA office within ten (10) days of the completion of said show. Sanctionor will not be responsible for incorrect results submitted by Sanctionee. Sanctionee will not hold Sanctionor responsible for the information or enforcement of Sanctionee's individual show rules. Sanctionee MUST provide the Approved hair Judge and the Approved Show Judge below. These are the sole responsibilities of the Sanctionee and must be approved by the JBBA Board of Directors prior to implementation.

6. **SANCTIONOR'S RESPONSIBILITIES:** Sanctionor agrees to provide the following as part of this sanctioning agreement.

\$100.00 Fee Includes:

- a) Advertisement and listing as an approved JBBA show in The Beefmaster Cowman, BBU Website, and Social Media Outlets
- b) Publication (news releases) of show results in The Beefmaster Cowman and results will be sent to the publications that are being used by Beefmaster Breeders United at that time for publication.
- c) Assistance with the assignment of a judge for the show from the JBBA approved judge's list.
- 7. **SANCTIONEE'S RESPONSIBILITIES**: Sanctionee agrees to provide the following as part of this sanctioning agreement:
 - a) Handle entries (fees and mailing)
 - b) All awards for show
 - c) Show photographer
 - d) Securing the arena (show site), including any deposits, clean-up fees, etc.
 - e) Personnel to check-in cattle, line-up classes, announce the show, work the ring, etc.
 - f) Payment for judge(s)
 - g) Premium payment to exhibitors (to be obtained from entry fees) and paid within fourteen (14) days of completion of show. Some additional funds may be available as decided by the JBBA Board of Directors and based on the number of head in the show.
